Indemnity and Waiver Agreement

Please read this carefully before booking.



In consideration for my permission to participate on this activity I agree to the following Indemnity and Waiver Agreement. I acknowledge that dogsledding has inherent risks, hazards and dangers for anyone who participates on this activity. I understand that these risks, hazards and dangers include:

1. The affection of the dogs to behave in ways and manners that may result in injury to persons near or around them
2. The unpredictability of the dog's reaction to such things as sounds, sudden movement, unfamiliar objects, persons or other animals
3. The collision during dogsledding with other animals, sledges or objects such as trees or rocks
4. The possible injuries resulting from use of an essential snow anker (sharp iron hook/brake)
5. The uncertain conditions of our trails in our areal which are depending on weather conditions
6. The exposure to possible unfamiliar temperature extremes and snow
7. The stage of overheating which may be caused by a non-reasonable physical condition

8. The stage of dehydration which may be caused by a non-reasonable physical condition
9. The injuries that result by missing of my own mobility to enter/exit and ride on the sledge
10. The ignorance of accepting and following instructions of the responsible guide

I understand the above described risks, hazards and dangers which may lead to sickness or injury. I expressly agree in the fact that dogsledding is at my own risk.  
I understand that this activity requires a reasonable physical and mental condition and I believe that I have the necessary physical condition and mobility to participate on this activity safely.  
I confess that I will not be under the influence of drugs or alcohol that would influence my capacity for participating in this activity.  
I acknowledge that I do not suffer from any medical disease such as epilepsy or heart problems.  
I further agree not to sue Senja Husky Adventure AS resulting from any sickness or injury in connection with my participation in the activity of dogsledding. In no event will Senja Husky Adventure AS or their co-workers be liable to any party for any direct, indirect, special or other consequential damages for any incident in relation of participation in dogsledding and the services provided by Senja Husky Adventure AS, including, but not limited to, health problems, death, lost profit, business interruption or other circumstances.

#### Cancellation/changes by you

In order to cancel or change your reservation, you need to contact Senja Husky Adventure AS.

- \* Cancellation can be made until 7 days before arrival/departure on your tour with a 100 % refund
- \* Cancellation between 7 and 2 days before arrival/departure on your tour will be made with a 50 % refund
- \* Cancellation between 2 and 0 days before arrival/departure on your tour will not be refunded.

A change from you is regarded as a cancellation.

#### Insurance/cancellation protection

We recommend all our customers to have good insurances before commencing their trip in case of illness, lost luggage, accidents and similar incidents.

#### Cancellations/Major changes from our side

Cancellations or major changes may occur if:

- \* conditions out of our control; the weather, accidents, strikes etc.
- \* conditions for the booking is not met; minimum number of participants, age etc.

If this type of cancellation happens, and you do not accept the alternative provided to you, we refund 100 % of the cost for that part of the reservation. In order to ensure a good experience for you, we might have to change minor details in your reservation. This may be caused by for example weather conditions.

#### Terms and conditions

#### Booking limitations

The booking system can handle reservations for up to 8 participants. You may order tours until 16:00 PM the day before the tour. Your reservation is confirmed when you receive a confirmation with a booking number. We recommend all our customers to print this confirmation and bring it on the tour. You need to be 18 years old in order to book tours with Senja Husky Adventure AS.

#### Payment and security

The payment is processed when your booking is made. Senja Husky Adventure AS is responsible for the transaction, and that the correct amount is withdrawn from your account. If there should be a problem with your credit card, we will contact you. If we aren't able to get in contact with you, your reservation will be cancelled. All personal information is handled on an externally encrypted site (SSL 128 bit) where your information is safe. Senja Husky Adventure AS will have access to your name and contact information. Your Credit card information is not shared with us, only with our payment provider Stripe. The information shared with us is just enough to identify the purchase for us.
